7. Sauk County Animal Shelter operations update :

Animal Shelter took in 47 dogs and adopted/reclaimed/transferred 41 dogs. They also took in 202 cats and adopted out/transferred out 49 in the month of August. The Animal Shelter also took in 2 rabbits, 1 hamster and 2 guinea pigs. They transferred 1 cockatiel. The Animal Shelter dealt with a total of 16 bite cases 9 dogs, 3 cats and 4 bats. They responded to 60 calls and impounded 11 dogs and 51 cats.
8. Review and approve August 2017, expenses for Coroner:

Motion by Deitrich, seconded by Kriegl to approve payment of the Coroner's expenses for August 2017 in the amount of \$6,954.60. Bills discussed. Motion carried.

Motion to approve the 2018 budget by Deitrich, seconded by Krueger with the recommendation to move \$35,000 from fund balance to offset the new total station expense. Krueger-Yes, Wenzel-Yes, Deitrich- Yes, Kriegl-No. Motion Carried.


