

VISITATION RULES/HOURS

1. No use of cell phones, cameras or recording devices of any sort in the visitation room.
All electronics, including cell phones, must be turned OFF prior to going into visitation.
2. No pictures/items may be shown without prior approval.
3. No food and/or drink in visitation - this includes for children also.
4. You must remain at the booth you are assigned to. Juveniles must remain with the adult visitor at the visitation booth.
5. If you leave the visitation room at any time during your visit, you may not go back into visitation.
6. You may only visit the inmate you are registered to see. Communicating with any other inmate will cause termination of the visit and may cause suspension of your visiting privileges.
7. Anyone under 18 must be supervised by an adult at all times; this includes in the parking lot area. Juveniles may not be left unattended in cars in the parking lot, on the sidewalk or in the lobby.
8. Swearing at and/or disrespect of staff will cause termination of the visit and may cause suspension of your visiting privileges.
9. Visitors must be dressed in shoes, a shirt, pants, shorts or a skirt/dress. Sheer, see through, or mesh clothing will not be allowed. Visitors wearing clothing too tight, too short, or too low will not be allowed to visit. No undergarments may be showing including bra straps; no cleavage or midriff may be visible. Arguing about your choice of dress will automatically disqualify you from visiting for the session.
10. Any indecent activity will cause termination of the visit and may cause suspension of your visiting privileges.
11. All visitors must be sober and not under the influence of alcohol or illegal drugs.
12. Anyone on a no contact list will not be allowed to visit that inmate.

VIOLATION OF THE RULES MAY CAUSE SUSPENSION OF VISITING PRIVILEGES.

PUBLIC VISITATION HOURS:

Visitors need to be registered at least 20 minutes prior to the end of the visitation session. Visitors coming for an extended visit need to arrive at least 40 minutes prior to the end of the visitation session and will be accommodated as time and space allows.

Morning Visitation: Tue-Sun 9am-10:30 am (all visitors must be registered by 10:10 am)

Evening Visitation: Tue, Wed & Thu 7pm-8:30 pm (all visitors must be registered by 8:10 pm)

Inmates on “room confinement,” or inmates involved in the various volunteer programs/job searches will not be getting visits while on that status. Inmates housed in Disciplinary Segregation are allowed one visit per week on Wednesday morning. If in doubt about visitation for an inmate, call **608-355-3210 to check their status - keep in mind an inmate’s status can change at any time.

ELIGIBLE VISITORS – a maximum of **3** visitors will be allowed per visit. An exception of 4 visitors may be allowed only with staff approval. Inmates are only allowed one visit per visitation session on a first come first serve basis.

- One visitor must be an adult (18 years old or older).
- Visitors must have a photo ID containing full name and date of birth. Acceptable ID’s are: Photo driver’s license, US State/Government issued photo ID, military photo ID card, Resident alien photo ID card, work photo ID card, or passport.
- Juveniles (17 years old or younger) must be accompanied at all times and in all locations (parking lot, lobby, visitation room) in the facility during the visit by an eligible adult visitor who is their parent, legal guardian or family member. All other rules apply as would for adult visitors.

HEARING IMPAIRED - ask for visitor booth 8 or 16 at the visitation counter.
