Instructions for Accessing Tax Parcel Information via Sauk County Website

1. Go to the Sauk County, Wisconsin website: www.co.sauk.wi.us
2. Click on “**Tax Data**” this will take you to “*Ascent Property Tax Land Records*” or follow the link listed below:

If the system is asking you to log in, arrow back and click on Tax Data again.
3. To search for your property, you will search by **ONE** of three methods. Parcel ID, address of property, or the name the property is recorded in.

- a. To search by Parcel ID: (example 002-1234-00000 in this example 002 is municipality code for Town of Baraboo and 1234-00000 is the Parcel ID)

Click the drop down arrow in the box titled “*Municipality*”. Choose the municipality the property is located in (Town of, Village of, or City of). Enter the remainder of the parcel number (xxxx-xxxxx) in the box titled “*Parcel ID*”. Click on “*Find Now*.”

- b. To search by address of the property: Enter the street number and street name (do not include St, Rd, Ave, etc) of the property you are looking for. Click on “*Find Now*.”

- c. To search by the name the property is recorded in: Enter the recorded name in the first name and last name fields or last name only in last name field. For a trust or a business, you will enter the trust name or business name in the last name field. Click on “*Find Now*.”

Pay Taxes

Click the **red Pay Taxes** button.

You will then be taken to a shopping cart showing the amount to pay. If you have any additional parcels (having the same recorded name) with an amount due, you will see them listed below. You can click Add to Cart to add these parcels to your cart and pay them in the same transaction. If you want to pay a different amount, enter the dollar you amount you wish to pay. Click the **red Pay** button.

(Note: If your shopping cart appears but has a zero balance, you will need to change your browser settings to allow popups.)

On the right of the screen, you will verify your payment amount and the amount you will be charged for the **convenience fee**. Read through the Terms and Conditions, **click I Agree to Terms and Conditions**, and click **Submit Payment** to finish your payment. A screen should appear with a copy of your payment receipt. If you entered an email address with your information, you'll also get a payment receipt emailed to you.
