### THIS LETTER IS TO VERIFY THE PRIMARY RESIDENT OF \_\_\_\_\_ FOR THE WISCONSIN LOTTERY AND GAMING CREDIT

PRIMARY RESIDENCE is defined as where you live 6 or more months a year; when you are temporarily away, it is the home to which you intend to return. *YOU CAN HAVE ONLY ONE PRIMARY RESIDENCE. YOU MAY RETURN ONLY ONE CLAIM FORM.* If you meet these requirements, you may claim the Wisconsin Lottery and Gaming Credit by filling out this form and returning it to our office. You may claim the Wisconsin Lottery and Gaming Credit, if **on or before January 1**, you were the owner of \_\_\_\_\_, and you used that address as your primary residence (check number 1 below). Please note that our office will update your mailing address to \_\_\_\_\_.

If you **did not** reside at this property **on January 1**, you are not eligible for this year's Wisconsin Lottery and Gaming Credit. However, if it is **after January 1**, and you plan to use \_\_\_\_\_ as your primary residence for the remainder of the year, you may be eligible for the Wisconsin Lottery and Gaming Credit payable on the following year's tax bill (check number 2 below). Please note that our office will update your mailing address to \_\_\_\_\_.

Once claimed, the lottery credit will appear on subsequent years' tax bills. The law requires that you **notify your county treasurer within 30 days after you no longer qualify** to claim the credit either because you no longer own the property or no longer use it as your primary residence (check number 3 below).
