Departmental Updates

UW Extension

ICC Meeting at Green Lake on March 17, 2017 - Dr. Karl Martin will give progress on the nEXT Generation project. Krueger encouraged members of this committee to attend. Ashford, Andrews, Spencer and Stehling plan to attend which would prompt a special meeting posting of a quorum.

Committee members encouraged to start thinking about what UW Extension should look like in Sauk County. Erickson suggested a Sauk County needs assessment.

Arts & Culture
