# What key messages should be conveyed to UWEX Administration at the July 27th ICC meeting?

- Sauk County UWEX, Arts and Culture Committee would like the option to offer UWEX programming at county level (not regional). This may require additional funding from county to make up for state cuts.
- Important to keep all four program areas 4H/Youth Development, Agriculture, Community/Economic Development and Family Living.
- Sauk County would like to dictate its own educational programs based on local needs.
- More public input is needed regarding future of UW Extension
