Zirzow proposed that the Sauk Co. Ag Society would like to request an additional \$10,000 for 10 years to build a new roof/concrete structure for the Swine/Poultry project for 2018 budget. Committee suggested looking into the Sauk Co. Revolving Loan Fund and possibly the Sauk Co. Development Corp. for loan options.

Motion by Spencer, second by Andrews to **approve** the Sauk County Ag Society outside request for **\$25,000 for** 2017. Motion carried, all in favor.
