Motion carried. All in favor.

# <u>Discussion, possible action on the Sauk County Ag Society (SCAS) Outside Agency appropriation request for 2019</u> budget

Motion made by Hazard, second by Newport to **approve** the Sauk County Ag Society Outside Agency appropriation request in the amount of \$25,000 for 2019. Motion carried. All in favor.
