# Briefly explain **Priority of Service** in the Public Labor Exchange / what it means:

Priority of Service in the Public Labor Exchange basically is that Veterans and eligible spouses take precedence over non-veterans in receiving services in Department of Labor (DOL) funded programs. For all practical purposes, this means that if you are determined/termed to be a Dislocated Worker by their program requirements, then the Workforce Investment Act (WIA) and Trade Adjustment Act (TAA) programs need to give you as a veteran, preference in providing services. The Final Rule (http://www.dol.gov/VETS/E8-30166.pdf) took effect on January 19, 2009. The Final Rule signals that those recipients of USDOL funds for qualified job training programs are subject to the priority of service regulations, and are required by law to provide priority of service to veterans and eligible spouses.

The Final Rule, and the priority of service it requires, is an important acknowledgement of the sacrifices of the men and women who have served in the U.S. Armed Forces. USDOL's strategic vision for priority of service to covered persons honors veterans and eligible spouses of veterans as our "heroes at home" and envisions that DOL-funded employment and training programs, including the publicly-funded workforce investment system, will identify, inform, and deliver comprehensive services to covered persons as part of strategic workforce development activities across the country.

    Veterans Preference Supplement form http://oser.state.wi.us/docview.asp?docid=1240
    - 1. I am a non-disabled veteran. (10 points)
    - 2. I am a disabled veteran whose disability is LESS THAN 30% and is service-connected. (15 points)
  - 3. I am a disabled veteran whose disability is 30% OR MORE and is service-connected. (20 points)
  - 4. I am a spouse of a disabled veteran whose disability is 70% OR MORE and is service-connected. (10 points)
  - 5. I am a disabled veteran whose disability is 70% OR MORE and is service-connected. (You must be a permanent state employee in classified service to be given preference on **promotional** exams.)
  - 6. I am an un-remarried spouse of a veteran who was killed in action OR died from a service-connected disability. (10 points)

- **5 point preference eligible** if your active duty service meets any of the following:
  - 1. 180 or more consecutive days, any part of which occurred during the period beginning September 11, 2001 and ending on a future date prescribed by Presidential proclamation or law as the last date of Operation Iraqi Freedom, OR
  - 2. Between August 2, 1990 and January 2, 1992, **OR**
  - 3. 180 or more consecutive days, any part of which occurred after January 31, 1955 and before October 15, 1976.
  - 4. In a war, campaign or expedition for which a campaign badge has been authorized or between April 28, 1952 and July 1, 1955.

### 10 point preference eligible if you served at any time, and you:

- 1. Have a service connected disability, **OR**
- 2. Received a Purple Heart.

#### Veterans' Recruitment Appointment (VRA):

Veterans' Recruitment Appointment (VRA) is an excepted authority that allows agencies, to appoint eligible veterans without competition. If you:

- a) Are in receipt of a campaign badge for service during a war or in a campaign or expedition; OR
- b) Are a disabled veteran, OR
- c) Are in receipt of an Armed forces Service Medal for participation in a military operation, **OR**
- d) Are a recently separated veteran (within the last 3 years), AND
- e) Separated under honorable conditions (this means an honorable or general discharge), you are VRA eligible.

### **Priority of Service for Eligible Veterans and Spouses**

The Jobs for Veterans Act affords priority of service to covered veterans and eligible spouses over non-covered persons for the receipt of employment, training, and placement services provided under new or existing job training programs funded in whole or in part, by the U.S. Department of Labor (DOL).

### **AM I ELIGIBLE?**

To be eligible for priority of service you must meet the following definition as a Covered Person. The term 'covered person' means any of the following individuals:

A veteran: A person who served in the active military, naval, or air service, and who was discharged or released under conditions other than dishonorable.

### NOTE:

- For National Guard & Reserve members, Basic Training, Initial Skills, other Skills training and/or Annual Training does NOT count as Active Duty time for assistance through the LVER / DVOP Program.
- National Guard & Reserve members MUST have been Federally activated under Title 10 to qualify.
- A Veterans Administration Service Connected Disability Rating (% rating) will qualify an individual to receive LVER / DVOP Program services.

*Eligible Spouse*: The spouse of any of the following individuals:

- o Any veteran who died of a service connected disability
- o Any veteran who has a total disability resulting from a service-connected disability.
- o Any veteran who died while a disability so evaluated was in existence.
- o Any member of the Armed Forces serving on active duty who, at the time of application for assistance under this section, is listed, pursuant to section 556 of title 37 and regulations issued by the Secretary concerned, in one or more of the following categories and has been so listed for a total of more than 90 days:
  - missing in action, captured in the line of duty by a hostile force, or forcibly detained or interned in line of duty by a foreign government or power.

### WHAT IT MEANS

Veterans priority of service means the right of eligible covered persons to take precedence over eligible non-covered persons in obtaining services. For example, this could mean:

The covered person receives access to the service or resource earlier in time than the non-covered person; or If the service or resource is limited, the covered person receives access to the service or resource before the non-covered person.

### WHAT ARE THE ELIGIBLE PROGRAMS?

Below is a list of programs affected by the passage of the priority of service law. This list is not all inclusive, but provides a good idea of the type of programs in which priority of service to qualified veterans exists. Before priority of service can be extended to any covered person in these programs, the covered person MUST be qualified to participate in the program.

- WIA Adult and Dislocated Worker
- Wagner-Peyser Employment Service
- Trade Act Programs
- National Emergency Grants
- Senior Community Service Employment Programs(SCSEP)
   Job Corps
- Career One-Stop Electronic Tools
- Other Internet-based self-service tools operated by DOL programs
- Migrant & Seasonal Farm Worker Program
- Indian and Native American Program
- WIA Demonstration Projects
- Labor Market Information Grants
