  - d. Hope House (Sathasivam) Shelter is very full. Had a recent resignation, so looking to add a person.
  - e. DOC (Rosciszewski) down 4 spots right now (so about half of the office). Columbia County is taking some Sauk cases. Billie Jo is now supervising non-sex-offender. Uptick in overdoses. Uptick in cases. Apparently now all SO treatment is going to be via Zoom.

- a. SART had 1 meeting. Looking to frame what SART is going to look like going forward. Looked to have one in April, but unable to meet. Then unable to meet in May due to quorum issues. Now set for 6/22 @ 1P.
